# European Commission: new platform to improve traceability of donated tissue and cells

From now on, all donated tissue and cells will be identified with a single European code. The European Commission has launched an online platform, containing all the codes across the Community. This will make it possible to trace all tissue and cells throughout the supply chain - from donor to patient - and to take appropriate measures in the event of any quality or safety issue.

# European Commission: report on the operation of the cross-border healthcare directive

Of the 23 Member States covered by the report, 18 have implemented mechanisms to restrict planned healthcare abroad. Belgium and Denmark have both received more than 30,000 claims for reimbursement.

In response to a question from the EP on the reimbursement of cross-border healthcare for patients who have been resident in a country for more than three months, but on a temporary basis, the European Commission confirmed that the social security legislation is

designed to ensure coverage of patients crossing borders. There is therefore no set time limit to define the duration of a 'temporary stay', which can thus be longer than three months.

#### European Commission: annual growth survey 2017

According to the policy guidelines for 2017, contained in the annual growth survey, health policies should support and reinforce social security nets and active inclusion strategies, through preventive, but also curative and rehabilitation policies.

#### European Commission: draft joint employment report 2017

The annual growth survey is accompanied by several policy reports, including an in-depth analysis of the economic and social situation and the labour market. According to this latter report, health reforms have been implemented in a number of Member States to boost the supply of and access to effective primary healthcare services, to streamline and increase the sustainability of specialist and hospital care and to improve access to affordable medicines. In many Member States, a significant share of the population still has difficulties accessing healthcare, particularly low-income households.

# 6 International trade agreements

### TTIP: significant progress on regulatory cooperation

At the close of the 15th round of negotiations, encouraging progress has been made in some areas, particularly the updating of the existing mutual recognition agreement on good manufacturing practices in the pharma sector.

## MERCOSUR: beginning of free trade talks

The 14th round of negotiations with a view to a free trade agreement between the EU and MERCOSUR (Argentina, Brazil, Paraguay and Uruguay, without Venezuela) were held in Brussels in October 2016. This was the first full negotiation round since 2012, and the first to be held since the exchange of market access offers (covering goods, services and public procurement).

The countries of the EU and ASEAN (Burma/Myanmar, Brunei, Cambodia, Indonesia, Laos, Malaysia, Philippines, Singapore, Thailand and Vietnam) have resolved to accelerate efforts in working towards a strategic partnership to govern bilateral relations, strengthening cooperation in traditional areas (trade, connectivity, development, energy and research), and in the field of security policy.

### Judgement: recourse to successive fixed-term contracts to cover permanent needs in the healthcare sector is contrary to EU law

In case C-16/15, the Court of Justice concluded that recourse to successive fixed-term contracts to cover permanent needs in the healthcare sector is contrary to EU law. The use of such contracts can only be justified by a need to cover temporary shortages.

# Opinion of the Advocate General: case involving a dispute between the German certification agency for PIP implants and a patient

In the opinion of the Advocate General, liability for defective products may be extended to actors other than the manufacturer itself, particularly notified bodies. 'Such bodies', therefore, 'may be liable to patients and users for a culpable failure to fulfill their obligations resulting from EU product safety rules'.

### Judgment: the fixed prices set in Germany for prescription-only medicinal products are contrary to EU law

In case C-148/15, the Court ruled on the lawfulness of German legislation setting fixed prices for prescription-only medicinal products dispensed by pharmacies. In the view of the Court, this type of legislation is incompatible with the European principle of free movement of goods, and cannot be justified on grounds of protection of the health and life of humans, nor by claims that it ensures better geographical distribution of traditional pharmacies.

### Judgment: confirmation of the Commission's decision to fine Lundbeck for delaying the marketing of generic medicines

The General Court of the EU has confirmed the fines of almost € 150 million imposed by the European Commission on several undertakings (Generics (UK), Alpharma, Arrow and Ranbaxy), in the context of an agreement intended to delay the marketing of generic versions of the antidepressant citalopram. The Commission concluded that the Danish pharmaceutical company Lundbeck, and four competitors active in the production or sale of generics, had concluded agreements against the interests of patients and healthcare systems.

# Judgment: supplementary pension regime, capital, Belgian health insurance and solidarity levies

In case C-269/15, the Court ruled that Belgium is not authorised to charge health levies (3.55%) and solidarity levies (2%) on payments made under supplementary pension schemes if the beneficiary of these supplementary pensions is not resident in that Member State and is subject to the social security legislation of the Member State of residence.

### Judgment: taxation of supplies of plasma to be used for the manufacture of medicinal products

In case C-412/15, the Court concluded that supplies of human blood which Member States are required to exempt by virtue of the VAT directive (Article 132(1)(d)) do not include supplies of plasma obtained from human blood, where that plasma is intended to be used not for direct therapeutic purposes but exclusively for the manufacture of medicinal products.

#### Opinion of the Advocate General: compatibility of the Belgian ban on advertising dental care with EU law

In case C-339/15, the Advocate General concluded that Belgian legislation prohibiting providers of dental care from advertising their services to the public constitutes a restriction on freedom of establishment and the freedom to provide services. This restriction is justified on grounds of the protection of public health, since the national legislation at issue does not have the effect of prohibiting such service providers from giving, in a telephone directory or other source of information accessible by the public, basic details making known their existence as professionals.

### Judgment: medicines prepared industrially or manufactured by a method involving an industrial process

In case C-276/15, the Court found that according to Directive 2001/83/EC, a medicinal product for human use which does not require a marketing authorisation by reason of the proven frequency with which it is prescribed by doctors or dentists, where the essential manufacturing steps take place in a pharmacy as part of normal pharmacy business and in reasonable quantities, and is intended for supply under the existing pharmacy operating license, cannot be regarded as having been prepared industrially or manufactured by a method involving an industrial process, within the meaning of that provision, and consequently does not come within the scope of that directive.

#### Judgment: pharmaceutical product placed on the export market and the import market by the trade mark proprietor with the same types of packaging

In case C-297/15, the Court found that a trade mark proprietor may object to the continued marketing of a medicinal product by a parallel importer where the latter has re-packaged that medicine in new outer packaging and reaffixed the trade mark, where, first, the medicinal product at issue can be marketed in the importing state in the same packaging, and, secondly, the importer has not demonstrated that the imported product can only be marketed in a limited part of the importing state's market.

#### Judgment: non-contractual liability regime

In case C-268/15, involving an action brought against the Belgian State by a clinical biology laboratory, the Court found that a Member State's system of non-contractual liability for damage caused by a breach of EU law does not apply in the case of damage allegedly caused to an individual as the result of an alleged breach of a fundamental freedom laid down in Articles 49, 56 or 63 TFEU by national legislation which is applicable without distinction to the State's own nationals and those of other States, where, in a situation which is confined in all respects within a single Member State, there is no link between the subject or circumstances of the dispute in the main proceedings and those articles.

### The Commission authorises the acquisition of Boehringer Ingelheim's consumer health service by Sanofi, subject to conditions

The European Commission has cleared the proposed acquisition of the consumer health service of Germany's Boehringer Ingelheim by the French undertaking Sanofi, subject to certain conditions being met. Both companies are active in the pharmaceutical sector.

The British Competition and Markets Authority (CMA) has launched an investigation into presumed infringements of competition law in the pharmaceutical sector. The investigation concerns suspected unfair pricing by way of charging excessive prices in the supply of certain pharmaceutical products, including to the National Health Service.

#### Italy: the ICA imposes a €5 million fine on the multinational company Aspen

The Italian Competition Authority (ICA) has imposed a fine of more than € 5 million on the multinational pharmaceutical company Aspen, following price increases of up to 1,500% for drugs irreplaceable in the treatment of oncohaematological patients, particularly children and older people.

### France: the Supreme Court upholds Sanofi's generic denigration fine

The French Supreme Court (Cour de Cassation) upheld the € 40.6 million imposed on Sanofi by the competition authority in May 2013, and confirmed the judgment of the Paris Court of Appeal. It found that Sanofi abused its dominant position by denigrating generic competitors of its drug Plavix on the French clopidogrel market.

#### Poland: price-fixing agreement by association of enterprises condemned

The Polish Office for Competition and Consumer Protection (OCCP) applied sanctions linked to an anti-competitive agreement entered into by the Association of Polish Centres for Infertility treatment and Reproduction Development.

The German competition authority has launched a sector inquiry into the hospital service, to examine and analyse competitive conditions in the sector, and to further develop examination criteria for the authority's merger control proceedings.

The Commission has found that five measures for purely local operations in Germany, Spain and Portugal involve no state aid because they are unlikely to affect trade between Member States. One of these decisions applies to Santa Casa da Misericórdia de Tomar (Portugal), which provides social assistance services to elderly and disabled people, as well as long-term care.
