EUROPEAN COMMISSION: New EU approach to cancer screening

The European Commission has proposed a Council recommendation to update cancer screening practices and, in particular, to increase the practice of screening for breast, colorectal and cervical cancer, as well as for prostate, lung and stomach cancer.

EUROPEAN COMMISSION: Communication to better prepare Member States for future epidemics

The European Commission has proposed a series of measures to avoid a sudden increase in COVID-19 cases and to strengthen the response capacities of Member States to future outbreaks. In addition to immunisation efforts, it calls for investments in strengthening healthcare systems and in the mental health of healthcare professionals.

ECDC: assessment report on the state of preparedness of European health systems for health crises

The report, published by the European Centre for Disease Prevention and Control (ECDC), assesses the preparedness of health systems in five countries (Germany, Croatia, Spain, Italy and Finland) during the first phase of the COVID-19 pandemic. Healthcare coordination is one of the areas studied. Conclusions are drawn to improve the assessment of European countries' preparedness for crises.

EUROPEAN COMMISSION: report on the impact of the COVID-19 pandemic on the mental health of young people

This report, published by the European Education and Culture Executive Agency (EACEA), analyses the measures taken at the European and national levels to limit the negative impact of COVID-19 on the mental health of young people. Access to mental healthcare services is also examined. The conclusion summarises lessons and proposes courses of action.

EUROPEAN COMMISSION: presentation of the work programme for 2023

In the field of health, the European Commission plans to continue the work that has already been started, like in the European Health Data Space, for example. In the fight against cancer, there is a recommendation about vaccine-preventable cancers. A commitment to a comprehensive approach to mental health is announced. Appendix 1 provides a list of planned initiatives.

MDCG: action list to facilitate the transition towards the revised regulations on medical devices and in vitro diagnostic medical devices

This list was adopted by the Medical Device Coordination Group (MDCG), composed of representatives from all Member States and chaired by a member of the European Commission. It aims to reinforce the capacity of notified bodies, and to prepare manufacturers for the implementation of European regulations regarding medical devices and in vitro diagnostic medical devices.

EMA, HMA: joint statement on the use of biosimilar medicines

The European Medicines Agency (EMA) and the Heads of Medicines Agencies (HMA) confirm the possibility of using highly similar medicines with another approved reference medicine (biosimilars) interchangeably with the reference medicine.

HERA: purchase of antiviral treatments against monkeypox

The European Commission's Health Emergency Preparedness and Response Authority (HERA) has purchased 10,000 treatments of Tecovirimat against monkeypox. Unlike past purchases, these treatments will now be channelled through the European Civil Protection Mechanism, RescEU.

ECA: assessment report on the EU COVID-19 vaccine procurement process

The report, published by the European Court of Auditors (ECA), assesses the implementation of the COVID-19 vaccine procurement framework, the negotiation strategy and the European Commission's monitoring of contract implementation. The Court concludes that the performance of the acquisition process was assessed too summarily. It recommends that lessons be learned for the future, and that the updated pandemic procurement framework be tested.

EUROPEAN COMMISSION: working paper on the weaknesses of the drug supply chain

The document presents the results of the structured dialogue on drug supply security. It highlights the key elements that are important to consider when analysing this domain. It identifies target areas at the EU level that can feed into future actions to secure the supply and availability of medicines, active pharmaceutical ingredients (APIs) and critical raw materials.

HERA, CEPI: cooperation in medical countermeasures against emerging infectious diseases

The Health Emergency Preparedness and Response Authority (HERA) and the Coalition for Epidemic Preparedness Innovations (CEPI) have announced their intention to further cooperate in supporting the development and procurement of medical countermeasures, and vaccines in particular. CEPI is a global partnership of public, private, philanthropic and civil society

organisations. This cooperation will focus on research and development, and on strengthening production capacities. It aims to better prepare for crisis management, and to limit the impact of epidemics both within the European Union and beyond.

EMA: public consultations on data quality and on the use of the metadata catalogue of realword data sources

The European Medicines Agency (EMA) has launched a public consultation on two documents. The first is the draft data quality framework for EU medicines regulation. The second document is a best-practice guide on the use of the metadata catalogue developed by the EMA on "real-world" data sources. These data can be used to inform research questions and in study protocols.

EUROPEAN COMMISSION: manufacturers of pharmaceutical products affected by the revised Urban Waste Water Treatment Directive

The European Commission has proposed to revise the Urban Waste Water Treatment Directive. A new system of increased producer responsibility will oblige producers to bear disposal costs. The list of water pollutants will also be updated to include certain pharmaceuticals used as pain relievers and anti-inflammatories, as well as antibiotics.

ESIP, MEDEV: proposals for the revision of European pharmaceutical legislation

The European Social Insurance Platform (ESIP) and the Medicine Evaluation Committee (MEDEV) have presented a list of amendments to current EU pharmaceutical legislation. In light of the review to be proposed by the European Commission, the two organisations recommend actions in two priority areas: the production of robust and timely evidence coupled with more transparency, as well as the improvement of accessibility by reinforcing competition.

EUROPEAN COMMISSION: report on the activities of the SOLVIT network since 2002

Published on the occasion of SOLVIT's 20th anniversary, this report traces the evolution of the network and the services it offers to help citizens and businesses solve problems they encounter regarding cross-border issues that violate single market rules. These issues include the recognition of professional qualifications and access to cross-border care.

EUROPEAN COMMISSION: two proposals for new rules on artificial intelligence liability and product liability

The first proposal aims to harmonise and facilitate access to compensation for victims who have been harmed by artificial intelligence (AI) systems, including those used in healthcare. The second proposal aims to revise the rules concerning the strict liability of manufacturers for defective products (from smart technologies to medical devices).

5 Social policy

EUROPEAN COMMISSION: publication of the European Care Strategy

The strategy aims to ensure affordable, accessible and high-quality care services throughout the European Union, and to improve the situation of care recipients and both professional and non-professional care providers. In addition to a specific recommendation concerning early childhood, the Commission presented a recommendation on access to affordable, high-quality, long-term care (home care, community care and residential care). An appendix outlines the principles to follow for high-quality, long-term care. A holistic approach is promoted to better integrate all care services, including health care.

EUROPEAN PARLIAMENT: resolutions on cross-border regions and on economic, social and territorial cohesion

With the resolution on cross-border regions of the European Union, the European Parliament welcomes the progress made in institutional cooperation, for example, through the pooling of healthcare facilities. However, it calls for maximum efforts to be made to eliminate the remaining barriers to accessing public services, including health services, and to the recognition of diplomas and other professional qualifications. The resolution on cohesion points out the lack of healthcare services in rural areas and the need to support these areas.

EUROPEAN PARLIAMENT: resolution on the new guidelines for the employment policies of Member States

In May 2022, the European Commission proposed the revision of certain guidelines for employment policies, including the guideline on promoting equal opportunities, strengthening social inclusion and combating poverty. In this regard, the European Parliament's amendments call, among other things, on Member States to ensure effective access to healthcare for children free of charge, as well as to ensure equal and effective access to public, sustainable, preventive and long-term healthcare services.

EUROPEAN COMMISSION: proposal for a recommendation on adequate minimum income to ensure active inclusion

The European Commission calls on Member States to modernise their minimum income schemes to make them truly effective in the fight against poverty and social exclusion. In particular, it calls on States to achieve adequate minimum incomes by 2030 and to improve beneficiaries' access to high-quality support services, such as healthcare. In a joint communication, the Commission assesses the distributional effect of Member States' policies, including access to healthcare.

6 EU funding

EU COUNCIL: adoption of the Netherlands' Recovery and Resilience Plan

This adoption comes after a positive evaluation by the European Commission. The plan contributes to the resilience of the Dutch healthcare system through measures such as creating a national pool of healthcare professionals to be deployed in times of crisis and strengthening e-health services for patients.

COURT OF AUDITORS: report on the evaluation of National Recovery and Resilience Plans (NRRP) by the European Commission

In this report, the European Court of Auditors examined the evaluation of NRRPs in six countries (Germany, Croatia, Spain, France, Greece, Italy). It concludes that the European Commission's assessment was generally appropriate, but notes that there are still risks to implementation, such as unclear milestones and targets. The final recommendations call, among other things, for improved evaluation procedures, as well as better monitoring of how actions taken contribute to the implementation of country recommendations, for example, in the health sector.

EUROPEAN PARLIAMENT: study on the impact of recent crises on the policy of cohesion

This study, commissioned by the Committee on Regional Development (REGI), analyses the impact of the COVID-19 pandemic and the war in Ukraine on cohesion policy. Among other things, investments in the healthcare sector are examined. For the period 2021-2027, the study notes a shift towards a more structured, long-term approach focused, for example, on financing new infrastructure, reorganising health services, prevention and e-health, and healthcare access for more vulnerable groups.

EUROPEAN COMMISSION: approval of two cross-border cooperation programmes for the period 2021-2027

The "Interreg POCTEP" programme supports cooperation between Spain and Portugal under the European Regional Development Fund. It aims to provide, among other things, better healthcare infrastructure and access to healthcare for people living in cross-border regions. The "Interreg NEXT Hungary-Romania-Slovakia-Ukraine" programme supports cooperation between these countries. This programme is dedicated to cooperation between Member States and neighbouring regions, and is allocated under the cohesion policy. One of the goals is to ensure equitable access to healthcare and to improve the resilience of health systems.

EUROPEAN COMMISSION: adoption of partnership agreements with Malta and Slovenia under the 2021-2027 cohesion policy

Both agreements provide funding for the health system. Malta will invest, among other things, in training and research in health fields. Slovenia plans to invest in long-term care and mental health services.

EUROPEAN COMMISSION: additional funding to Bulgaria, Spain and Slovakia within the framework of the REACT-EU programme

These funds are granted within the framework of the Recovery Assistance for Cohesion and the Territories of Europe (REACT-EU) programme. In all three countries, they will be used to invest in the recruitment and retention of healthcare professionals.

EUROPEAN COMMISSION: funding to Latvia under the 2021-2027 cohesion policy

The funding received will be used, among other things, to invest in health care. Latvia is especially aiming to improve access to affordable, quality healthcare services and long-term community care.

EUROPEAN COMMISSION: revised communication on state aid rules for research, development and innovation

This communication simplifies and updates the 2014 research, development and innovation (RDI) framework. This framework sets out the rules under which Member States may grant state aid to companies for RDI activities, while ensuring a level playing field. The new rules are adapted to the current strategic priorities of the European Union, including the European Health Union. Annex 1 specifies the eligible costs for health-related research and development projects.

EUROPEAN COMMISSION: ban on Illumina's acquisition of GRAIL

GRAIL and Illumina are two American companies specialising respectively in cancer screening tests and genomic sequencing. The European Commission's decision is justified on the grounds that the acquisition would have stifled innovation and reduced choice in the emerging market for early cancer detection blood tests. The Commission also renewed and adapted the existing interim measures to keep the two companies separate and to limit the negative impact on market competitiveness.

EUROPEAN COMMISSION: communication on grievances addressed to Teva for anticompetitive practices with multiple sclerosis drugs

Teva is a global pharmaceutical company based in Israel. According to the European Commission, it abused its dominant position in Germany, Belgium, Spain, Italy, the Netherlands, Poland and the Czech Republic, in order to delay competition against its multiple sclerosis drug Copaxone.

EUROPEAN COMMISSION: public consultation on the draft revised communication on market definition

Market definition is an important first step in the review of mergers and most cases of anti-competitive practices. It defines the perimeter within which competition takes place, including in the healthcare and pharmaceutical sectors. For the definition of pharmaceutical markets, for example, the Commission will take into account their particularities linked to the presence of different stakeholders (and interests). The new communication is scheduled for release in the third guarter of 2023.

Norstella, based in the United States, is a group of information and intelligence providers for the pharmaceutical and medical technology industries, among others. Citeline, based in Luxembourg, provides specialised business intelligence, data and software to the pharmaceutical, consulting, financial, biotechnology and medical technology industries. Hg is a British company that invests in software and service companies. WCAS is a U.S. private equity fund focused on investing in healthcare and technology. Warburg Pincus is an American private equity firm active in various sectors.

EUROPEAN COMMISSION: authorisation of the acquisition of joint control of Green Veracity Acquisition Holdings by LGP and CVC

Green Veracity Acquisition Holdings is a U.S.-based company that provides pre-trial deposition and litigation support services in Canada and the United States. LGP, also based in the U.S., invests in companies that provide services to healthcare companies, among others. CVC is a Luxembourg-based company that manages investment funds.

EUROPEAN COMMISSION: authorisation of the acquisition of joint control of Fedrigoni by BC Partners and Bain Capital

Fedrigoni is an Italian-based manufacturer and global supplier of speciality paper products and self-adhesive materials. BC Partners, based in the United States, is an international private equity firm with a portfolio of companies that are active in various sectors, including healthcare. Bain Capital, based in the UK, is an international private equity firm active in a variety of sectors, including healthcare.

Wishcard is a provider of corporate gift vouchers and gift cards, based in Germany. Oakley, also based in Germany, and EMZ Partners, based in France, are two private equity funds that invest in medium-sized companies active in various sectors. IK, based in Luxembourg, is a private equity fund active in various sectors, including healthcare. Valentin Schütt is a natural person and founder of Wishcard.

8 Infringement proceedings

BELGIUM: failure to transpose EU rules governing regulated professions

The European Commission has decided to refer Belgium to the Court of Justice of the European Union, along with a proposal to impose financial penalties, for its failure to transpose the Directive on a proportionality check prior to its adoption of a new regulation of professions (Directive 2018/958/EU). Healthcare professions are covered by this directive.

BULGARIA, LATVIA: transposition of EU rules on radiation protection

The European Commission has sent a letter of formal notice to Bulgaria requesting the correct transposition of the revised Basic Safety Standards Directive (Directive 2013/59/Euratom) regarding radiation protection into its national legislation. These standards aim to ensure the highest level of radiation protection for workers, patients and the public throughout the Union. It has also decided to bring an action against Latvia before the Court of Justice of the European Union for its failure to fully transpose the same directive.

POLAND: non-compliance with EU regulations on parallel imports of medicines

The European Commission has sent a letter of formal notice to Poland for non-compliance with EU rules on the free movement of goods regarding the parallel import of medicines (Articles 34 and 36 TFEU). In particular, the Commission is asking Poland to revise certain provisions relating to the granting and expiry of an authorisation for the parallel import of medicines.

POLAND, SLOVAKIA, SLOVENIA: incomplete transposition of EU regulations on digital content

The European Commission has sent a reasoned opinion to Poland, Slovakia and Slovenia for the incomplete transposition of the Digital Content Directive (Directive (EU) 2019/770). While this Directive does not directly apply to healthcare and prescription health devices, it does apply to any digital content and services making up a medical device that can be obtained without a prescription from or provision by a healthcare professional.

OPINION: concept of global marketing authorisation for a pharmaceutical product

In her opinion on joined cases C-438/21 P to C-440/21 P proposed to the Court of Justice of the European Union, the Advocate General focuses on the conditions required to authorise the marketing of a medicinal product in the EU and to assess whether two medicinal products fall under the same global marketing authorisation. She also discusses the relationship between the competences of the Commission, the European Medicines Agency (EMA) and Member State authorities within the context of this assessment.

JUDGMENT: notions of insurance intermediary and insurance distributor

Case C-633/20 concerns the interpretation of the provisions of the Directive on Insurance Mediation and the Directive on Insurance Distribution. According to the Court, the concept of "insurance intermediary" and, consequently, that of "insurance distributor", includes a legal entity whose activity consists of offering their customers a subscription, on a voluntary basis and in return for a fee that is received from said customers, to a group insurance policy to which they have previously subscribed with an insurance company, with the intent that this subscription entitles these customers to insurance benefits in the event of illness or an accident abroad, in particular.

ESPN: report on the long-term care systems in place in the 27 countries of the European Union

This report by the European Social Policy Network (ESPN) identifies six models of social protection applied to long-term care for people aged 65 and over. The following trilemma is put forward: ensuring adequate coverage of needs through affordable and quality services; determining the place of informal caregivers, while ensuring that informal care is not an obligation and that these caregivers are adequately supported; investing in long-term care in times of budgetary restraint.
